8.1.2.4 In order to run for election for an Board of Directors position, a candidate must:

*Category A: Professional*

1. hold an active IAAO designation
2. has attended and passed the examination for at least three (3) thirty- (30-) hour IAAO courses (effective January 1, 2015)
3. is an IAAO accredited member
4. has served as an IAAO instructor
5. has served as a designation grader
6. has served as a professional designation advisor

*Category B: Internal*

7. has been a member of IAAO for at least five (5) years
8. has served on an IAAO committee
9. has served as an IAAO representative
10. has served as an officer in a local chapter of IAAO

*Category C: External*

11. holds a State or provincial or country designation/certification
12. have attend at least two (2) IAAO Annual Conferences within the previous five (5) years
13. has authored an article in an IAAO publication within the last five (5) years
14. has served as an officer in an IAAO affiliate organization
