Barbara G. Brunner Scholarship Fund

Scholarship Guidelines

The Barbara Brunner Scholarship Fund was established in 2003 to help qualified IAAO members attend the annual conference. The fund is named in honor of Barbara G. Brunner, a long-time member, former President and supporter of IAAO.

Scholarships will be awarded sixty days prior to the Annual Conference. Applications must be received ninety days prior to the conference to be considered. If funds are available and less than three (3) awards have been made when the deadline has passed in any year, awards may be made up to a total of three (3) on a first come first served basis to those who meet all criteria except for applying by the deadline.

IAAO members interested in applying for a Barbara G. Brunner Scholarship must meet the following requirements:

- An applicant must be a member in IAAO for at least two years.
- Applicants must submit a statement of need for the scholarship.
- Applicants must submit the required application form ninety days prior to the annual conference.
- Scholarships will be awarded in an amount that will cover the registration fee for the Conference, not to exceed \$500.
- The applicant will be notified of approval sixty days prior to the Conference.
- Scholarship recipients will be ineligible for another award for a period of three years.
- Only one applicant from an assessment office may receive a scholarship in a calendar year.
- Applicants who decline the scholarship after approval must reapply for future consideration.

The Barbara G. Brunner Scholarship Fund Committee will approve the applicants and notify IAAO. Scholarships will be awarded based on the applications, funds available and any other factors the committee deems necessary. Total scholarships granted in any year may not exceed 15% of the income available in the fund.
